TAX EXEMPTIONS

Based on the local tax regulations in Egypt both contributions of employer and participant employee are subject to the following exemptions:

- Employer Contribution: Tax exempted up to 20% of total annual payroll
- Employee Contribution: Tax exempted up to 15% of employee annual salary

FWA tool is an automated tool that flags suspicious claims according to pre-built scenarios

FWA Capabilities

- FWA tool is designed to capture suspicious claims either on insured, provider, or client level.
- It also captures trends that may be alarming, either in providers or clients behaviors.
- Once a suspicious case is detected, it's communicated to the network, portfolio & sales teams so we can all start working to stop the behavior.

Common Scenarios

- Several members from the same policy, going to the same pharmacy, in the same date & for same medications could be fraudulent.
- Member & all his dependents taking same medications at the same time might be suspicious.
- Member having more than 3 different conditions in the same month, with more than 4 pharmacy claims could be fraudulent.
